Minutes of the Regular Town Board Meeting

December 8, 2020 - 7:00 p.m.

The regular town board meeting was called to order at 7:00 p.m. by Board Chair Maureen P. Lien. Board Supervisors Jim Lowrey and Jeff Notstad, Clerk/Treasurer Kathy Wilson, Madeline Westberg, and Cindy and Mike Cutrano also attended this meeting.

PROCEDURAL

- a. Discussion/possible action regarding the Town Cemetery in Utica.
The Town is still waiting for surveyor Dave Riesop to submit the final survey to Dane County..

- a. Discussion/possible action regarding support for the expansion of the Cambridge Volunteer Fire/EMS Station.

Board Supervisor Jim Lowrey made a motion to place a non-binding referendum on the April, 2021 election ballot seeking input from the town electors on whether or not to fund expansion of the Cambridge Volunteer Fire/EMS facility. Board Supervisor Jeff Notstad seconded the motion.

- b. Discussion/possible action regarding renewal of the Town's contract with Gardiner Appraisal for assessment services.

- c. Discussion/possible action regarding Cambridge Area Resource Team (CART).

Board Chair Maureen Lien told the Board that the Cambridge Fire/EMS will need to purchase a new vehicle to transport fire/EMS personnel to emergencies since its current transport vehicle is 28 years old and is non-compliant with current safety regulations.
